All the aforesaid are 4 distinct registered societies under The Societies Registration Act, 1860 having separate Memorandum and Rules & Regulation. In order to conduct the elections the said 4 societies, vide letter dated 24.06.2025 the undersigned three persons have been appointed as "Election Officers" with one of us as "Chief Election officer" to conduct the elections on 03.08.2025, however owing to some rectification in the voter list, the elections were postponed and now vide letter dated 31.10.2025 we again have been asked to conduct the elections on 30.11.2025. Along with the letters, we have been entrusted current applicable Memorandum, Rules and Regulations along with list of "Voters" of respective societies duly signed by its office bearers with position of membership as under:-

Nomination forms shall be duly filled with completion of all the other formalities i.e. accompanied by aadhar card of candidate, proposer, seconder and payment proof of nomination fees either by way of demand drafts in favour of the name of society or by way of RTGS/ NEFT/online transfer with following particulars:-

- Without the proof of the payment and submission of aadhar cards not only the nomination form shall not be accepted but also in case of nonreconciliation of payment at any point of time in future, nomination form shall be liable to be rejected.
2. All the submissions of documents, forms, letters, objections by all the stake holders shall be in physical form at Society office i.e. 5, Khandelwal Digamber Jain Mandir Complex, Raja Bazar, Connaught Place, New Delhi- 110001 and should reach the society maximum by the cut off time as given. In no case, any delay in this regard shall be entertained for any reason whatsoever i.e. postal delay, traffic jams etc., all the persons shall take necessary pre-cautions in this regard and shall make their necessary arrangements to adhere the cut off time and date.
3. Any further information, list, guidelines, Rules, Regulations etc. to be issued in terms of aforesaid schedule or otherwise with respect to the entire elections process, shall be published in the aforesaid website i.e. www.digjainmahasabha.org and shall be pasted on the notice board of the society office i.e. 5, Khandelwal Digamber Jain Mandir Complex, Raja Bazar, Connaught Place, New Delhi-110001 and no personal information shall be given to anybody. Accordingly, all the persons shall keep themselves updated in this regard by way of aforesaid two modes.
4. The casting of vote can be done by any Voter by way of his/her "proxy" who can be any voter of that society only. For the purpose of Proxy voting, proxy form of voter duly filled, signed and accompanied by aadhar card of both the voters shall reach the office of society i.e. 5, Khandelwal Digamber Jain Mandir Complex, Raja Bazar, Connaught Place, New Delhi-110001 in physical form for the purpose of verification to be done at Society office.
5. The election officer shall have full authority to reject any proxy form and no objections in this regard shall be entertained by Election officers on any ground whatsoever during the election processes.
6. "One person one proxy" i.e. one person cannot be proxy for more than one person.
7. For voting by "Raise of Hands" or "Placement of Sitting" or by "Secret Ballot", all the voters including proxy voter(s) shall remain present physically along with their original Aadhar card / other photo identity Card. In the absence they shall not be allowed to participate in voting process.
8. There shall be no rule of casting of vote by postal ballot.
9. Voting by secret ballot system, if any, shall be by issuance of ballot papers and thereafter casting of vote by giving only one choice against one post by marking the choice clearly in the space provided in the box against each post. In case of any discrepancy like double choice, choices given at the margin etc., the vote shall be considered as invalid.
10. To decide any issues with respect to any of the aforesaid elections steps/proceedings including changes in the aforesaid dates and timings as per the situation and need arises, decision shall be taken by the Chief Election Officer and other two officers.
11. The office of the society shall remain open on all the aforesaid dates despite the said date being otherwise holiday.
12. Nobody should declare himself/herself as a winning candidate of the elections before the declaration of election results by election officers on 30.11.2025. In case of any self declaration prior to 30.11.2025, the same shall be considered as a serious defiance to the present rules and regulation and shall lead to rejection of nomination form of the said candidate at any stage upto the declaration of results subject to decision of by election officers on 30.11.2025.
13. This notification shall supersede the earlier election notification 31.10.2025 published in Jain Gazette dated 10.11.2025 in case of any contradiction.
14. The voters shall vote in their respective Mahasabha only.
